

CNS SUMMIT PRIVACY POLICY

This Privacy Policy (“Policy”) explains how CNS Summit (“CNS Summit”, “us” or “we”) collects and protects your personal information and how your personal information is being used by us in connection with your use of our products and services, including use of the Website. This Policy describes the types of information we may collect from you or that you may provide when you consume our products and services or visit the website cnssummit.org (together with any affiliated websites, blogs, email correspondence via the Website and mobile services, the “Website”) and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This Policy applies to information we collect:

- when you register to attend our events or otherwise consume our products and services.
- on this Website, including through use of Google Analytics.
- in email, text, and other electronic messages between you and this Website.

It does not apply to information collected:

- offline or through any other means, including on any other website operated by Company or any third party; or
- by any third party, including through any application or content (including advertising) that may link to or be accessible from or through the Website.

Please read this Policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your only choice is not to use our Website. By accessing or using this Website, you agree to this Policy. This Policy may change from time to time. Your continued use of this Website after we make changes is deemed to be acceptance of those changes, so please check back periodically for updates.

Information We Collect About You and How We Collect It

We collect several types of information from and about users of our Website, including information:

- by which you may be personally identified, such as name, postal address, email address, telephone number, or any other identifier by which you may be contacted online or offline (“Personal Information”);
- that is about you but individually does not identify you, such as information we collect automatically as you navigate through the Website, view or download videos or use certain other Website features, which includes usage details, IP addresses and information collected through cookies and other tracking technologies; and/or
- about your internet connection, the equipment you use to access our Website, and usage details.

We collect this information:

- directly from you when you provide it to us, such as when you register or set up an account, make a purchase, subscribe to a newsletter, search queries, details of transactions you carry out through our Website, fill out a form or otherwise enter information on our Website, information we request when you report a problem with our Website, and records and copies of your correspondence if you contact us; and

- automatically as you navigate through the site, such as usage details, traffic data, logs and other communication data, the resources that you access and use on the Website, IP addresses, operating system and browser type, and information collected through cookies, flash cookies, web beacons, and other tracking technologies.

We also may use these technologies to collect information about your online activities over time and across third-party websites or other online services (behavioral tracking). [Click here](#) for information on how we respond to web browser signals and other mechanisms that enable consumers to exercise choice about behavioral tracking.

The information we collect automatically is only statistical data and does not include Personal Information, but we may maintain it or associate it with Personal Information we collect in other ways. It helps us to improve our Website and to deliver a better and more personalized service, including by enabling us to:

- estimate our audience size and usage patterns
- store information about your preferences, allowing us to customize our Website according to your individual interests
- speed up your searches
- recognize you when you return to our Website

The technologies we use for automatic data collection may include:

Cookies (or browser cookies). A cookie is a small file placed on the hard drive of your computer. You may refuse to accept browser cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our Website. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you direct your browser to our Website.

Flash Cookies. Certain features of our Website may use local stored objects (or Flash cookies) to collect and store information about your preferences and navigation to, from, and on our Website. Flash cookies are not managed by the same browser settings as are used for browser cookies. For information about managing your privacy and security settings for Flash cookies, see [Choices About How We Use and Disclose Your Information](#).

Web Beacons. Pages of our Website and our newsletter may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit us, for example, to count users who have visited those pages or opened a newsletter and for other related Website statistics (for example, recording the popularity of certain website content and verifying system and server integrity).

We do not collect Personal Information automatically, but we may tie automatically collected data to PII about you that we collect from other sources or you provide to us.

Does our Website allow third-party behavioral tracking?

It's important to note that, apart from the Google services described below, our policy is to not allow third-party behavioral tracking. However, we do not control third party websites, tracking technologies or how they use their tracking technologies. If you have any questions about an advertisement or other targeted content, you should contact the responsible provider directly.

Google Analytics

We may use Google Analytics on our Website from time to time. We have implemented the following services:

- Google Display Network Impression Reporting
- demographics and Interests Reporting

Google Analytics uses first-party cookies and third-party cookies (such as the DoubleClick cookie) or other third-party identifiers together to compile data regarding user interactions as they relate to our Website.

How do we use your information?

We may use the information we collect from you or that you provide to us, including Personal Information, in the following ways to:

- present our Website and its contents to you and personalize your experience and to allow us to deliver the type of content and offerings in which you are most interested
- provide you with information, products or services that you request from us
- fulfill any order or other purpose for which you provide it
- carry out our obligations and enforce our rights arising from any contracts entered into between you and us, including for billing and collection
- allow you to participate in interactive features on our Website
- allow us to better service you in responding to your customer service requests
- administer a promotion, survey or other Website feature
- send periodic emails regarding your order or other services and other direct marketing purposes
- follow up with you after correspondence (live chat, email or phone inquiries)
- notify you about changes to our Website or any products or services we offer through it

We may also use the information in any other way we describe when you provide the information, or for any other purpose with your consent

As such, you consent to our use and disclosure (see below) of any information submitted to us via our Website or information collected when you access the Website in any manner, and you acknowledge that you have no expectation of privacy, confidentiality or privilege in such information, except where required by law.

When do we disclose your information?

We may disclose aggregated information about our users, and information that does not identify any individual, without restriction.

We may disclose Personal Information that we collect, or you provide as described in this Policy to:

- our subsidiaries and affiliates
- contractors, service providers, and other third parties we use to support our business
- collect analytics (or more information, see Google Analytics)
- fulfill the purpose for which you provide it

We may also disclose the aggregated information for any other purpose disclosed by us when you provide the information or with your consent.

We may also disclose your Personal Information:

- to comply with any court order, law, or legal process, including to respond to any government or regulatory request
- to enforce or apply our terms of use, if any, and other agreements, including for billing and collection purposes
- to investigate and help prevent potentially unlawful activity or activities that threaten the integrity of our Website or network
- if we believe disclosure is necessary or appropriate to protect and defend the rights, property, or safety of CNS Summit, the Website, our customers, or others. This includes exchanging

information with other companies and organizations for the purposes of fraud protection and risk reduction.

Choices about how we use and disclose your information

We strive to provide you with choices regarding the Personal Information you provide to us. We have created mechanisms to provide you with the following control over your information:

Tracking Technologies. You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent. To learn how you can manage your Flash cookie settings, visit the Flash player settings page on Adobe's website. If you disable or refuse cookies, please note that some parts of this site may then be inaccessible or not function properly.

Promotional Offers from the Company. If you do not wish to have your contact information used by the Company to promote our own or third parties' products or services, please see our [Opt-Out Policy](#). This opt out does not apply to information provided to the Company as a result of a service experience or other transactional communications with the Company.

We do not control third parties' collection or use of your information. However, these third parties may provide you with ways to choose not to have your information collected or used in this way. You can opt out of receiving targeted ads from members of the Network Advertising Initiative ("NAI") on the NAI's website.

Opt-Out Policy

How do you get my consent?

By using our Website, you consent to our collection of non-Personal Information. If you do not consent to the collection of non-Personal Information, your only recourse is to not use this Website. When you provide us with Personal Information to set up an account, register for an event, complete a transaction, or verify your credit card information, you consent to our collecting it and using it for that specific reason only. Please note that at times we may need to send you email communications that are transactional in nature such as payment confirmations, which are communications you will not be able to opt-out of.

If we ask for your Personal Information for a secondary reason, like marketing, we will either ask you directly for your express consent, make the submission entirely optional, or provide you with an opportunity to opt-out.

How can I opt-out?

You may also send us an email at secretariat@cnssummit.org to request access to, correct or delete any Personal Information that you have provided to us. We cannot delete your Personal Information except by also deleting your user account. We may not accommodate a request to change information if we believe the change would violate any law or legal requirement or cause the information to be incorrect.

Please note that opt-out requests or requests to access, correct or delete your Personal Information may take up to ten (10) business days to process.

How do we protect your information?

We implement a variety of security measures on our Website. Our Website is scanned on a regular basis for security holes and known vulnerabilities in order to make your visit to our Website as safe as possible. We use regular Malware Scanning. Your Personal Information is accessible by a limited number of persons who have special access rights to such systems and need to access the information in order to perform their duties. In addition, all transactions are processed through a gateway provider and the sensitive/credit card or payment information you supply is encrypted via Secure Socket Layer (SSL) technology. We do not process or store any payment transactions on our servers.

Unfortunately, the transmission of information via the internet is not completely secure. Although we do our best to protect your Personal Information, we cannot guarantee the security of your Personal Information transmitted to our Website. Any transmission of Personal Information is at your own risk. We are not responsible for circumvention of any privacy settings or security measures contained on the Website.

No sale of Personal Information to third parties

We do not sell, trade, or otherwise transfer your Personal Information to outside parties for purposes of advertising, soliciting or telemarketing.

Third-party services

In general, the third-party providers used by us will only collect, use and disclose your information to the extent necessary to allow them to perform the services they provide to us.

However, certain third-party service providers, such as our meeting registration platform, payment gateways and other payment transaction processors, have their own privacy policies in respect to the information we are required to provide to them for your purchase-related transactions. For these providers, we recommend that you read their privacy policies so you can understand the manner in which your Personal Information will be handled by these providers.

In particular, remember that certain providers may be located in or have facilities that are located in a different jurisdiction than either you or us. So, if you elect to proceed with a transaction that involves a third-party service provider, then your information may become subject to the laws of the jurisdiction(s) in which that service provider or its facilities are located.

Once you leave our Website or are redirected to a third-party website or application, you are no longer governed by this Privacy Policy.

Third-party links

We do not include or offer third-party products or services on our Website. We may from time to time include third-party links to the websites, apps or social media accounts of our patrons, sponsors, partners and other similar persons or parties. When you click on such a link, it will direct you away from our Website. We are not responsible for the privacy practices of other websites and we encourage you to read their privacy statements.

Exclusions; Unsolicited information

This Policy does not apply to any information collected by CNS Summit other than information collected through the Website, when you consume our products and services, and in email, text or other electronic

messages between you and the Company. This Policy shall not apply to any unsolicited information you provide to us through the Website, posting to public areas of the Website or any other means.

Children under the age of 16

Our Website is not intended for use by children, especially those under 16 years of age. No one under age 16 may provide any information to or on the Website. We do not knowingly collect personal information from children under 16. If you are under 16, do not use or provide any information to this Website or provide any information about yourself to us, including your name, address, telephone number, email address, or any screen name or user name you may use.

When it comes to the collection of Personal Information from children under the age of 16 years old, the Children Online Privacy Protection Act ("COPPA") puts parents in control. The Federal Trade Commission, United States' consumer protection agency, enforces the COPPA Rule, which spells out what operators of websites and online services must do to protect children's privacy and safety online. We do not knowingly solicit, market or collect Personal Information from children under the age of 16 years old. If we learn we have collected or received personal information from a child under 16 without verification of parental consent, we will delete that information. If you believe that a minor has disclosed Personal Information to us, please report this to us immediately by emailing: secretariat@cnssummit.org. Fair Information Practices

The Fair Information Practices Principles form the backbone of privacy law in the United States and the concepts they include have played a significant role in the development of data protection laws around the globe. In order to be in line with Fair Information Practices we will notify our users within 1 business day should we learn of a data breach.

DO NOT TRACK Disclosures: Your web browser may allow you to send a 'do not track' request with your browsing traffic so you can browse anonymously. We honor Do Not Track ("DNT") signals and do not track, plant cookies, or use advertising when a DNT browser mechanism is in place. DNT is a standard that is still under development, so CNS Summit will continue to develop its Privacy Policy in accordance with best business practices. This **Privacy Policy for California Residents** ("CA Policy") supplements the information contained in the [Policy](#) and applies solely to all visitors, users, and others who reside in the State of California ("consumers" or "you"). **We adopt this notice to comply with the California Consumer Privacy Act of 2018 (CCPA) and any terms defined in the CCPA have the same meaning when used in this CA Policy.**

This CA Policy does not apply to workforce-related CA personal information collected from California-based employees, job applicants, contractors, or similar individuals; such notice is provided separately to impacted individuals.

Information We Collect

We collect information that identifies, relates to, describes, references, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer, household, or device ("CA Personal Information"). CA Personal Information does not include:

- Publicly available information from government records.
- Deidentified or aggregated consumer information.

In particular, we have collected the following categories of CA Personal Information from consumers within the last twelve (12) months:

Part 99))	Education records directly related to a student maintained by an educational institution or party acting on its behalf, such as grades, transcripts, class lists, student schedules, student identification codes, student financial information, or student disciplinary records. K. Inferences drawn from other personal information to create consumer profiles	Profile reflecting a person's preferences, characteristics, psychological trends, predispositions, behavior, attitudes, intelligence, abilities, and aptitudes.	NO
L. Sensitive personal information (SPI)	Personal information that reveals a consumer's: government identifiers (social security, drivers' license, state identification card, or passport number); complete account access credentials (usernames, account numbers, or card numbers combined with required access/security code or password); precise geolocation; racial or ethnic origin; religious or philosophical beliefs, or union membership; citizenship or immigration status; genetic data; mail, email, or text messages contents; unique identifying biometric information; health information; and sex life or sexual orientation information. We obtain the categories of CA personal information listed above from the following categories of sources:

- Directly from you. For example, from registration forms you complete (online or offline) or products and services you purchase.
- Indirectly from you. For example, from observing your actions on our Website.

We only use or disclose SPI for Permitted SPI purposes. We do not collect or process any personal information that would normally fall within one of the SPI categories to infer characteristics about a consumer.

Use of CA Personal Information

We may use or disclose the CA Personal Information we collect for one or more of the following purposes:

- To fulfill or meet the reason you provided the information. For example, if you share your name and contact information to ask a question about our products or services, we will use that CA Personal Information to respond to your inquiry. If you provide your CA Personal Information to purchase a product or service, we will use that information to process your payment and facilitate delivery. We may also save your information to facilitate new orders.
- To support, personalize, and develop our Website, products, and services.
- To process your requests, transactions, and prevent transactional fraud.
- To respond to your inquiries, including to investigate and address your concerns and monitor and improve our responses.
- To personalize your Website experience and to deliver content and product and service offerings relevant to your interests (with your consent, where required by law).
- To help maintain the safety, security, and integrity of our Website, products and services, databases and other technology assets, and business.
- For testing, research, analysis, and product development, including to develop and improve our Website, products, and services.
- To respond to law enforcement requests and as required by applicable law, court order, or governmental regulations.
- As described to you when collecting your CA Personal Information or as otherwise set forth in the CCPA.
- To evaluate or conduct a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which CA Personal Information held by us about our consumers is among the assets transferred.

We will not collect additional categories of CA Personal Information, including Sensitive Personal Information (SPI), or use the CA Personal Information we collected for materially different, unrelated, or incompatible purposes without providing you notice.

In the normal course of business we retain the CA Personal Information for the time period necessary to fulfill the intent under which the information was collected.

Sharing CA Personal Information

We may share your CA Personal Information by disclosing it to a third party for a business purpose. We only make these business purpose disclosures under written contracts that describe the purposes,

require the recipient to keep the CA Personal Information confidential, and prohibit using the disclosed information for any purpose except performing the contract. In the preceding twelve (12) months, Company has disclosed CA Personal Information for a business purpose to the categories of third parties indicated in the chart below.

We do not sell CA Personal Information. In the preceding twelve (12) months, Company has not sold CA Personal Information. For more on your CA Personal Information sale rights, see [Personal Information Sales Opt-Out and Opt-In Rights](#).

Your Rights and Choices

The CCPA provides consumers (California residents) with specific rights regarding their CA Personal Information. This section describes your CCPA rights and explains how to exercise those rights.

Right to Know and Data Portability

You have the right to request that we disclose certain information to you about our collection and use of your CA Personal Information over the past 12 months (the "right to know"). Once we receive your request and confirm your identity (see [Exercising Your Rights to Know or Delete](#)), we will disclose to you:

- The categories of CA Personal Information we collected about you.
- The categories of sources for the CA Personal Information we collected about you.
- Our business or commercial purpose for collecting or selling that CA Personal Information.
- The categories of third parties with whom we share that CA Personal Information.
- If we sold or disclosed your CA Personal Information for a business purpose, two separate lists disclosing:
 - sales, identifying the CA Personal Information categories that each category of recipient purchased; and
 - disclosures for a business purpose, identifying the CA Personal Information categories that each category of recipient obtained.
- The specific pieces of CA Personal Information we collected about you (also called a data portability request).

Right to Correct

You have the right to request that we correct any of your CA Personal Information that we collected from you and retained (see [Exercising Your Rights to Know or Delete](#)).

Right to Delete

You have the right to request that we delete any of your CA Personal Information that we collected from you and retained, subject to certain exceptions (the "right to delete"). Once we receive your request and confirm your identity (see [Exercising Your Rights to Know or Delete](#)), we will review your request to see if an exception allowing us to retain the information applies. We may deny your deletion request if retaining the information is necessary for us or our service provider(s) to:

1. Complete the transaction for which we collected the CA Personal Information, provide a product or service that you requested, take actions reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform our contract with you.
2. Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity, or prosecute those responsible for such activities.
3. Debug products to identify and repair errors that impair existing intended functionality.

4. Exercise free speech, ensure the right of another consumer to exercise their free speech rights, or exercise another right provided for by law.
5. Comply with the California Electronic Communications Privacy Act (Cal. Penal Code § 1546 *et. seq.*).
6. Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when the information's deletion may likely render impossible or seriously impair the research's achievement, if you previously provided informed consent.
7. Enable solely internal uses that are reasonably aligned with consumer expectations based on your relationship with us.
8. Comply with a legal obligation.
9. Make other internal and lawful uses of that information that are compatible with the context in which you provided it.

We will delete or deidentify CA Personal Information not subject to one of these exceptions from our records and will direct our service providers to take similar action.

Only you, or someone legally authorized to act on your behalf, may make a request to or delete related to your CA Personal Information.

You may also make a request to know or delete on behalf of your child.

You may only submit a request to know twice within a 12-month period. Your request to know or delete must:

- Provide sufficient information that allows us to reasonably verify you are the person about whom we collected CA Personal Information or an authorized representative.
- Describe your request with sufficient detail that allows us to properly understand, evaluate, and respond to it.

We cannot respond to your request or provide you with CA Personal Information if we cannot verify your identity or authority to make the request and confirm the CA Personal Information relates to you.

You do not need to create an account with us to submit a request to know or delete. We will only use CA Personal Information provided in the request to verify the requestor's identity or authority to make it.

Response Timing and Format

We will confirm receipt of your request within ten (10) business days. If you do not receive confirmation within the 10-day timeframe, please [Contact Us](#).

We endeavor to substantively respond to a verifiable consumer request within forty-five (45) days of its receipt. If we require more time (up to another 45 days), we will inform you of the reason and extension period in writing.

We will deliver our written response by mail or electronically, at your option.

Any disclosures we provide will only cover the 12-month period preceding our receipt of your request. The response we provide will also explain the reasons we cannot comply with a request, if applicable. For data portability requests, we will select a format to provide your CA Personal Information that is readily useable and should allow you to transmit the information from one entity to another entity without hindrance.

We do not charge a fee to process or respond to your verifiable consumer request unless it is excessive, repetitive, or manifestly unfounded. If we determine that the request warrants a fee, we will tell you why we made that decision and provide you with a cost estimate before completing your request.

CA Personal Information Sales Opt-Out and Opt-In Rights

If you are age 16 or older, you have the right to direct us to not sell your CA Personal Information at any time (the "right to opt-out"). We do not sell the CA Personal Information of consumers we actually know are less than 16 years old. Consumers who opt-in to CA Personal Information sales may opt-out of future sales at any time.
